1 - What is the 24th CBAr International Arbitration Conference?

It is an annual event that brings together scholars and those interested in arbitration, enabling interaction amongst academics, lawyers, arbitrators, experts and students from Brazil and abroad.

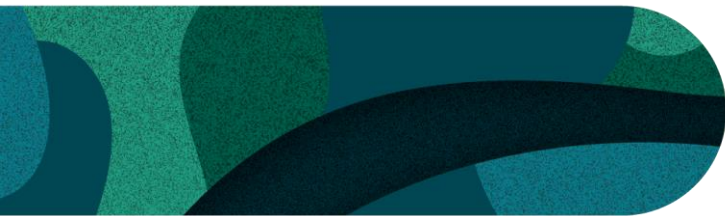

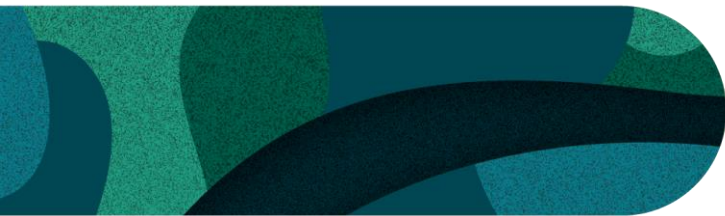

11 - What are the methods of payment?

- Credit Cards: Mastercard, Visa, Elo, American Express, Hipercard or Diners.
- NuPay
- iFood Benefícios

If the payment is not approved by the card issuer, the registration will be automatically cancelled.

Once payment is confirmed, the participant will receive the registration confirmation and a QR code in the registered email. The QR code is required to check-in at the event and to get the identification badges.

12 - Will I be informed that my registration is complete?

Yes, once payment is processed in our system, you will receive the confirmation of your registration in the registered email address, with the respective QR Code. It is necessary to check in with the QR Code on Conference days.

13 - I made a registration and did not make the payment, what will happen?

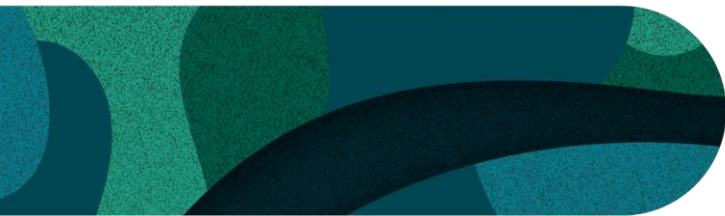
The non-paid registrations will be cancelled automatically.

14 - Is it possible to request the cancellation of an already paid registration?

Paid orders may be canceled within seven (7) days of purchase, provided that the cancellation request is submitted at least 48 hours prior to the start of the event. To request a cancellation, it is necessary to access the registration made on Sympla and submit the cancellation request. Only the transfer of ownership of the registration will be allowed, after 7 (seven) days. If it was a group purchase, no partial cancellation of the order will be allowed.

15 - How and when will the refund of the orders cancelled in accordance with the deadline above-mentioned be made?

After discounting any services fee from the purchase amount, and the purchaser's credit card administration fee, the refund will be made in the following terms and deadlines:

- Cancellation of purchases made by credit card: For purchases made by credit card, Sympla will refund the amount to the same card used for the purchase, and the amount can be credited in up to 2 bills.

16 - I just made my registration and realized that I filled in some wrong information. Can I change it?

Only the name of the participant can be changed in the registration system. The other information cannot be changed. If the registration has not been paid yet, it will be automatically cancelled after the payment due date and you will be able to make a new registration with the correct information.

Yes, the name can be changed directly in the registration system only once, up to one day before the event.

18 - Will I receive a certificate for participating in the Conference?

Yes, those who registered and attended the event will receive a certificate of participation.
